With reference to the above cited subject, as per reference (1) a Fire Safety Recommendations Certificate was issued to the School management for the observations are rectified within 90 days.


As per reference (2) the School management rectified the observations, submitted the staffs training certificates and other requirements and 'Fire Safety Compliance Certificate' was issued.
